How scores were determined

The aim of the Safe Climate Scorecard was to rank each candidate and party on their climate ambition. A team of Tasmanian Climate Collective members developed a 14 question questionnaire (see below) to determine their stance on climate action. These questions were developed based on the leading science of the best ways for Tasmania to reduce its emissions.

Each question had a set of scores, as shown below. We had four scorers who scored the answers 'blind', so they were unaware of the name of the candidate to remove any biases. The existing policies of political parties were also taken into account.

Some of the major parties did not reply to our questionnaire. As such, scores for Labor and Liberals were based on their existing policies. For the Jackie Lambie Network, they did not reply to our questionnaire and do not have any existing policies, as such they have been marked as poor (an asterisk explaining this has been added to the scorecard).

Responses were classed into categories as follows:

81-100%	three green ticks
71-80%	two green ticks
61-70%	one green tick
41-60%	orange ~ symbol
31-40%	one red X
16 - 30%	two red X
0-15%	three red X

Questionnaire Questions and Scoring

Tasmania's current greenhouse emissions targets are weak as they rely on the land sector to 'offset' emissions from other sectors. We need emissions targets for each sector. Will you support legislated targets and funding to reduce greenhouse gas emissions from each economic sector by at least 60% by 2030 (compared with 2005) and a 2050 target of near zero net emissions for each sector?
